## “So Ya Wanna Lead, Do Ya?”

July 23rd was the beginning of the twenty-sixth annual leadership workshops at McKendree College in Lebanon, Illinois. Under the direction of Gary ZumMallen, current IASC Workshop Director, the workshops were expanded to three sessions instead of two as in previous years.

The delegates, not knowing what challenges and situations they would be confronted with in the next four days, reluctantly arrived at the registration table. Room assignments, keys, and group folders were distributed to the delegates by staff members.

The action began Monday evening with dinner. Afterwards, delegates divided up into their groups to have pictures taken. Next came the first general session in Upper Deneen. Everyone, being unacquainted with many of the people present, looked for someone they knew. Mr. ZumMallen started by welcoming everyone to the workshop. Advisers and Junior Coun-

selors were then introduced. Ed Phelps, executive secretary and consultant for the workshops, spoke briefly on leadership and upcoming events of the week. The “principal” gave the delegates some background information pertaining to the imaginary school they would be attending for the next week. The format of the school had been decided by the staff the previous day.

From that time on the delegates were no longer from different schools, but were united as students from the same school located in Lebanon. The students would learn to work together in club situations and at least one extra-curricular activity.

At the first club meeting, under the direction of a J.C. and a Senior Adviser, the group was instructed to find a problem common to most high schools and come up with a solution. This established the group name and its purpose.

As Monday drew to an end the delegates gather outside on the steps of Deneen. It was here that Jim Fitzgerald, better known as Fitz, stepped into his role as songleader, accompanied by Father Bob. This nightly experience seemed to draw the delegates closer to each other.

For the remainder of the week role playing and group participation were major learning experiences for the delegates. Club activities included the writing of the constitution, election of officers, determining ways of making a student council function properly, and playing "Prisoners Dilemma," an exercise that teaches a very important lesson about cooperation, collaboration, and trust.

In general assemblies, Ed Phelps led seminars and other activities. These activities included, slips, head bands, squares, the NASA test, and games to demonstrate group dynamics, group communication, and consensus seeking exercises.

Tuesday evening workshop seminars were held covering such topics as: parliamentary procedure, money making projects, school assemblies, public relations, and an explanation of the IASC.

On Wednesday evening delegates were divided up into swap shops according to population of schools. The time allotted for swap shops provided the students with a chance to discuss problems and solutions common to each other's school.

The workshops not only gave time for learning experiences, but also for fun and entertainment. One evening was devoted to Junior Olympics which consisted of "Almost Anything Goes" type games. Other activities included intramurals, Talent Night, a movie, and a dance, not to mention the lion hunt Fitz took everyone on.

As the week progressed delegates no longer sat with old acquaintances, but rather with new ones. The enthusiasm at the last general session clearly showed that the delegates were ready to return to their schools and make their Student Councils more efficient.

As Friday rolled around no one wanted to leave. They knew it would be a while before they could see each other again. But even though the workshop was over, the memories will always remain.

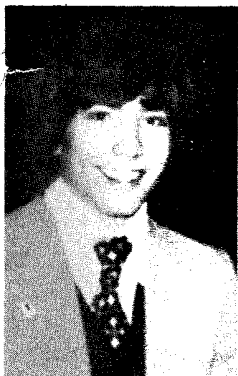

## BRIEFS From BRAD

One of the opportunities I had while campaigning for this office last April at the state convention was that of fielding a great number of questions regarding my views about the IASC. Most of the questions dealt with my plans for the coming year and the manner in which I hoped to carry them out. One of the questions was different, however, and it still sticks in my mind, even though the convention has long since passed.

The story goes something like this: I was walking the halls with my campaign manager trying to drum up some support for the election. We approached a group of delegates who had gathered and one of them asked, "What is the reason for the IASC?"

I began to answer by telling them everything that came to mind in reference to the purposes and structure of the IASC, but before I had gotten very far, they interrupted me and pointed out that I was not answering their question: "What is the *reason* for the IASC?" I was at a loss for words because I had never really questioned why there is, in fact, such an organization as the IASC.

This being the beginning of another year of activities, now might be an appropriate time to discuss the reason for an IASC. I am not writing in an attempt to justify our existence, as there is really no need for that; the IASC has already established itself as one of the foremost council associations in the nation. Rather, I will merely be trying to give some rationale as to why your council decides to join the IASC year after year, some schools being on the 44th consecutive year.

The answer might lie somewhere in the old cliché, "whatever is worth doing at all is worth doing well." By being elected to student council, you have been given a mandate by your friends and fellow students to represent them. By this election, they obviously placed some trust in you. I contend that it is now your duty and obligation to serve your student body in the best possible fashion. This means that your council must be continually trying new projects in addition to improving upon past ones in order to remain in stride with the needs of today's students. Student councils, therefore, have need of a vehicle through which they can learn of new and better ways to serve their school. I believe the IASC provides this through the many discussion groups and seminars it presents and through all of the written material it publishes.

Another explanation for the growth of the IASC might be that student councils need effective leaders and it is not often that a great leader will emerge to lead your school to a brighter tomorrow. To realize their full leadership potential, most people need instruction into the many aspects of leading people. The IASC attempts to provide this training by sponsoring the great number of workshops that it does.

I can think of many other possible reasons for the IASC, and I am sure other people would give different explanations. It is my hope that you will be interested in finding out more about the IASC. If so, I encourage you to contact me and relay any concerns you may have. If I don't know an answer, chances are that I can put you in touch with somebody who does.

In conclusion, I believe that the IASC exists because some students seek the best student council possible and are willing to look to our organization for help.

# IASC INVADES

On June 22nd around 8:15 P.M., two Greyhound buses with 96 Illinois delegates left Chicago for Marlboro, Massachusetts to attend the National Association of Student Councils (NASC) convention.

Before arriving at Marlboro, they visited various places along the way. The first stop was Gettysburg, Pennsylvania, where they toured the battlegrounds. Later that day they went to Washington, D.C. and saw the Capitol, the Lincoln and Jefferson memorials, and the White House.

Friday the delegates visited Williamsburg, Virginia. Here they saw the Colonial Village, the House of Burgesses, and the Governor's Mansion.

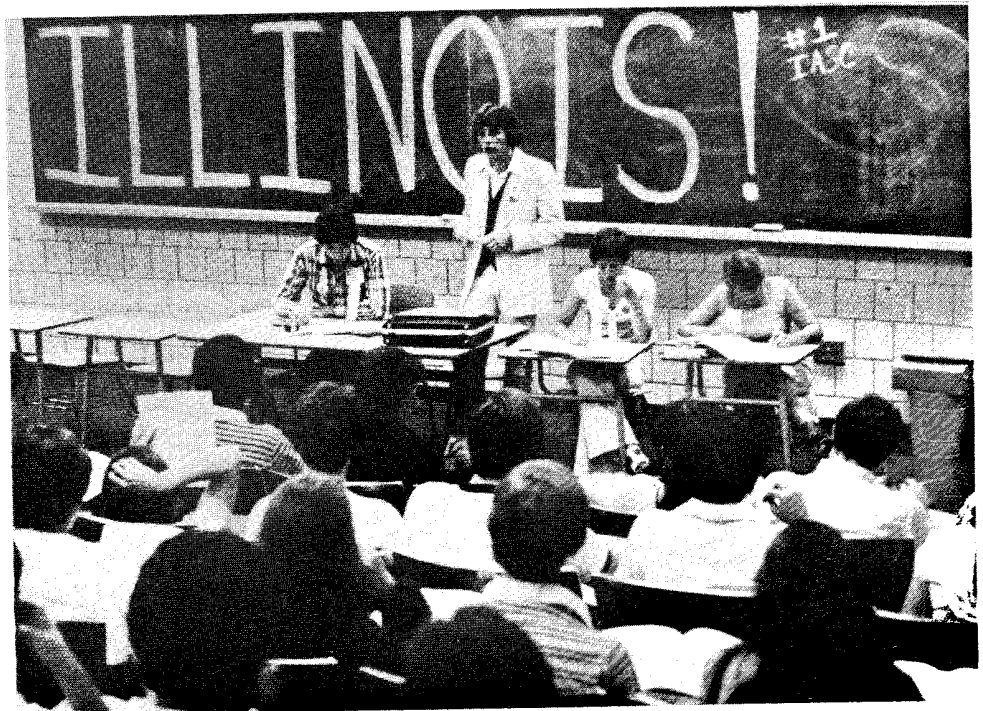
The final stop before the convention was New York City. A night bus tour amidst rain took them by the Empire State Building, Macy's, the Statue of Liberty, and Times Square. They also saw Chinatown, the Brooklyn Bridge and Greenwich Village.

On Sunday, June 21, they were one of the first states to arrive at Marlboro High School in Massachusetts. They found their host families and went home to get ready for the evening program.

That night, they found themselves among 1600 shouting, excited delegates from every state in the entire nation.

During the opening session each state's executive secretary and president were presented. Edmund Phelps and Brad Whitehead saw their names on the big screen facing the huge crowd. A proud Illinois never ceased clapping for those two "young" men.

An address was then given by Joseph P. Kennedy II, son of the late Senator Robert F. Kennedy, ending the program.



*1st Vice President, Keith Smiley, addresses Illinois Delegates*

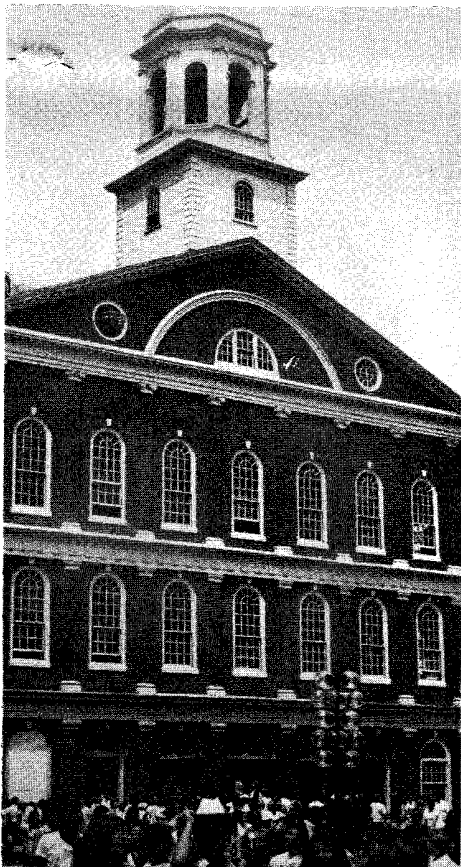
# MARLBORO COUNTRY

Monday morning there were state and regional meetings, followed by three workshops. Keith Smilie, First Vice President of IASC, was a discussion group leader. That evening entertainment was provided by "Up With People" singers and dancers. Says one of the singers: "We've never had such a response from an audience like we did from these young people It was fantastic."

Tuesday, the delegates toured Boston. The day consisted of visiting the Suffolk University auditorium to hear Frederic Storaska speak out on "Rape Prevention." There was the historic session at the old North Church where Paul Revere saw the lanterns hanging in 1775. Lunch was at Waterfront Park, followed by a conference at the Massachusetts State House, with representatives of "Youth Conferences With Older Americans."

At the John McCormack Building, delegates chose one workshop to attend. After the workshop came the tour of the famous Quincy Market. It had outdoor food shops, markets, and flower shops. At Faneuil Hall, a one-man show in which the actor, portraying eight different characters, gave views of the events at Lexington, Concord, Bunker Hill, and the hanging of Nathan Hale. Throughout the tour, the groups were split into four sections; each group visiting a spot at a different time . . . .

The groups were united at the City Hall Plaza at 5:00 P.M. and greeted by Massachusetts' Governor Michael Dukakis.

The evening started with a dolphin show on the Discovery Ship, a clam-bake (minus the clams, unfortunately) and a tour of the New England Aquarium Center on Boston Harbor.

The program started with remarks from Bruce Noses, 1975-76 co-chairperson NASC Advisory Committee, then a song by the talented Jimmy Lee, Student Council member of Marlboro High School. "Mr. Phil" Gugliuzza, Louisiana's State Executive Secretary, had a sing-along, and told his story of the warm fuzzies.

Wednesday, June 29 the students staggered to state meetings and then to a General Assembly, where an address

was given by Greg Schneiders, Staff Assistant to President Carter. Again there were two afternoon workshops, followed by "Tuned In," an educational, multi-media show, telling the story of how radio and television have shaped life in America.

The students went home to prepare for the banquet. At 7:00 P.M. the banquet took place at Chateau de Ville where all 1600 delegates gathered for a delicious chicken dinner. The Marlboro Student Council was then recognized for their excellent job.

The final address was given by Mr. Earl Reum, known as "Mr. Student Council," who asked such questions as, "Do you know where you're going?"

The dance was the finale and music was provided by "Freewheelin'" from Champaign, Illinois.

Thursday, it was time to leave. Illinois was gone by 9:30 A.M. Later that day, they stopped at Niagara Falls in Canada and went straight home from there.

By Friday morning at 9:30 A.M. the buses pulled into Chicago. There were many teary good-byes and promises to write. After all, who could forget the memories of this trip? For over five days, the Illinois delegates sang, "We all live in a Greyhound bus," because they certainly did.



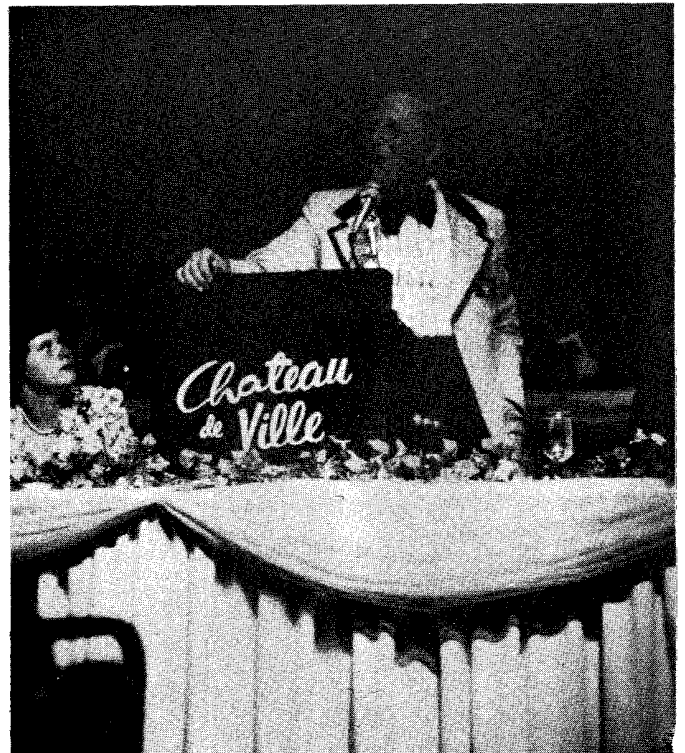


*The 1977 Illinois Delegation that invaded Marlboro Country*

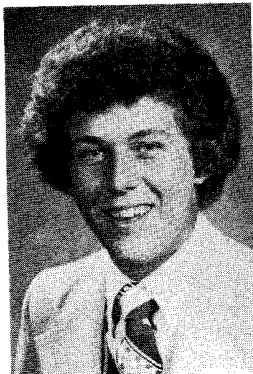

## Out-of-Quota Convention Positions

The duties of the Discussion Group Leader, and the Credentials and Resolutions Committees are as follows:

*Discussion Group Leaders.* organize and stimulate positive interaction for constructive discussion pertaining to the subject. The position of Discussion Group Leader is very important; the success of the convention will largely depend upon the effectiveness of your Discussion Group session. Each selected leader has a specific task to perform during his or her session. You must keep in mind many students will reach conclusions on your topic and apply them to their school. You are expected to prepare handouts, outlines, etc. Position Status-Out of Quota or In Quota Delegate.

*Credentials Committee* consists of one student selected from each of the respective IASC Districts. The committee interviews and screens all candidates seeking a position as an IASC officer. The committee will check if candidates have followed proper procedures and guidelines. The officer candidate must be approved by the committee before campaigning.

(Note): You may have a student on this committee and run a candidate for office. This committee is very important. It has an indirect hand in determining the success of the IASC. Position Status-out of Quota or In Quota Delegate.
